# **Husbandry:**

Cleaning frequency is based against cage numbers. Base changing is performed in a HEPA filtered change station which remains positive to the room environment. Gloved hands are disinfected between each cage. Diet is fed ad-libertum.

# **Housing System:**

Individual Ventilated Cages maintained at positive pressure to the room with an average of 60 HEPA filtered air changes per hour.

Dysmorphology Citrobacter Challenge

# **Supplementary Notes:**

A preconditional strain may be mated to a FLPeR strain to delete the region of DNA flanked by FRT sites which includes the selectable cassette. Genotype confirmation of the deletion event should be carried out. The resulting conditional strain may be further progressed to incorporate Cre deleter transgenes to remove critical coding region(s) as desired.
